Issues common to Indigenous communities across the globe: Land-grabbing, land rights & native titles, extraction and mining, security, migration and forced displacement, militarization and occupation of IP communities, IP legal status (lack thereof) and identity, self-government/ self-determination & treaty, IP language, right to forests and natural resources, neo-liberalism/ free market economy & economic injustices, globalisation & new forms of colonisation, discrimination and racism, depopulation, ethnic conflict, religious conflict and religious fundamentalism, climate change and environmental catastrophes, rising sea levels, stolen generations/ residential schools aftermath, youth incarceration & suicide, water security, ocean and river rights, domestic violence and abuse, gender violence, education, poverty, employment, agriculture, female genital mutilation, pipelines at SR, protection for land/water/fish/animals, trafficking (sex trafficking targeting IP women), Reconciliation processes, drug and substance abuse/ addiction, sustainable long-term living in harmony with nature – hunting and fishing rights, reindeer herding, IP & church/ Christianity – leadership development/ theological education & ecumenical formation, reclaiming traditional customs and practices for sustainable living and for future generations, political killings/ murders/ violence...

- Workshops/ Warshas Possible workshop themes suggested included climate change & migration, stolen generations: colonisation and human trafficking, commercialisation of earth, security/ militarism and the impact on women and children (who is the real terrorist?), life in all its fullness: food and water security, land rights/ exploitation/ mining/ green energy on IP land, Indigenous faith: inter religious dialogue and inter faith relations, Indigenous culture/ID/ Language and urbanisation, Indigenous land, healing & reconciliation. Again names and bios of workshop leaders to be emailed to the Programme Executive asap. Each workshop should work towards a concluding statement to add to the outcome declaration of the whole conference;
